

# Inside Breastfeeding USA September 2020

## **Greetings from the Board of Directors**

I want to start by saying that I hope all of our volunteers and families out west are safe from the devastating fires of the last few weeks and that those impacted by the recent hurricanes are also back home and safe. What a year this has been, and it feels strange to talk about finances while we all grapple with larger global concerns. That said, it's my job as Treasurer to keep you abreast of all that is happening under the financial umbrella. Our 2019-2020 fiscal year ended in June. We drafted the budget for this year in May and June, and our year-end reporting just wrapped up a couple of weeks ago, so now seems like a good time for a few updates.

Due largely to the pandemic and economic crisis, we ended the last fiscal year well below our budgeted spending. We also saw a decline in membership, but it seems to have leveled off. As a result, we ended fiscal year 2019-2020 about \$7,000 below budgeted net revenue. We are on solid financial footing, with one year's expenses held in a CD and a significant cushion beyond that. We anticipate that overall giving may be considerably lower in the 20-21 fiscal year, and we are planning for significantly lower income as a result. Because we are on solid footing and know that the needs in our communities are great right now, we are anticipating more spending than income in the coming year. It is important that we are wise with how we utilize organizational funds, particularly this year. This should be a temporary circumstance, and we are examining other avenues of support, such as grants, to potentially offset needed expenses. Planned spending in 20-21 includes hiring an equity consultant to help address systemic racism and other discrimination within our organization, continued maintenance of and updates to our website, continuing education investments, a full course evaluation to confirm our BC training is up-to-date and meeting the needs of adult learners, and Chapter grants, along with general expenses like insurance and a bookkeeper. These are all much needed pieces for keeping our organization moving forward.

Additionally, the Board of Directors recently voted to make a one-time investment in organizations serving Black, Indigenous, and people of color communities. Breastfeeding USA is donating \$5,000 to 4 different organizations (\$1,250 each), a number chosen because it represents the usual budget for a board retreat, which was canceled in 2020. So far, we have made a donation to <a href="BSTARS">BSTARS</a>, <a href="Fayetteville Breastfeeding Center">Fayetteville Breastfeeding Center</a>, and <a href="YOLO">YOLO</a> on behalf of <a href="Feed">Feed</a> the Babes. They are doing the vital work in communities where Breastfeeding USA does not have a presence. We will share the final donation once a nonprofit is chosen.

## **COVID UPDATE**

We've had a few folks asking when in-person meetings might resume, and we wanted to share an update. Many of us are missing our in-person connections right now and can't wait to resume meetings in our communities. In examining this question, we considered the best interest of our communities, turned to the CDC, and requested guidance from our insurance company.

As of this writing, 185,000 Americans have died from COVID-19, case rates are still high across most of the nation, and there is not yet a widely available vaccine or treatment. In the interest of

public health and protecting the families we serve, it is wise to continue offering our services in a remote fashion to protect against the spread of coronavirus.

Our insurance contact advised that we would be open to liability if someone were to get sick at one of our meetings and suggested we follow CDC guidance for reopening. The CDC still advises that the lowest risk activities should be prioritized:

"Lowest risk: Meetings and other activities are conducted virtually. Only essential activities (i.e., provision of essential services) occur in person."

The CDC also lays out guidelines for sanitation, ventilation, and personal behavior like masks that we do not have the resources to manage.

Breastfeeding support is an essential service, but if a breastfeeding dyad needs hands-on support, odds are they need help that's out of scope for a Breastfeeding Counselor. As a volunteer peer-support organization, we should continue to prioritize community health and minimize the spread of COVID-19 while providing online help and referring to IBCLCs with appropriate PPE as necessary.

Meetings under the Breastfeeding USA banner should remain remote for the foreseeable future.

#### **How to Provide Support**

We are fortunate to have a motivated and engaged group of volunteers helping us to employ many different platforms to provide distance-only breastfeeding support.

Breastfeeding USA has always supported BCs in providing remote support via phone, email, and Facebook. Facebook engagement is up, both on the national page and in several closed Facebook groups. We are currently having the greatest impact with outreach on Facebook, as that is where the largest number of parents come for questions and support. We also have folks managing Instagram and sharing personal stories there. Patty Jacobs is managing our Twitter account, which was recently recognized as a source of current scientific information about COVID-19 and breastfeeding.

**You can still hold meetings** via Zoom, WebEx, Google Meet, or other video conferencing platforms. For information about the Breastfeeding USA paid Zoom account, Google Meet, and guidelines for digital meetings, please read this document:

**You can still have one-on-one conversations.** Previous methods of communication such as phone, text, e-mail, etc. continue to be appropriate. You can also use Zoom, Google Meet, etc., as noted above.

Your other birth- and breastfeeding-related work is different from Breastfeeding USA work and is not affected by Breastfeeding USA's suspension of in-person meetings. Some BCs also act as IBCLCs, doulas, midwives, physicians, nurses, therapists etc., and it's important to clarify that any in-person activities you engage in under these auspices are not Breastfeeding USA activities. We often talk about this as "wearing separate hats."

The Board will discuss this guideline regularly and keep abreast of the changing circumstances.

Thank you for your continued support of breastfeeding families. We are so thankful for all of our volunteers and wish you and your families safety and good health.

From USBC: "Almost a quarter of all births in the US are to Latinx parents. While 80% of Latinx in the United States initiate breastfeeding indicating an intent to breastfeed, unfortunately, only 16% can meet the national guidelines of six months exclusive breastfeeding (recommended by APP and WHO) suggesting that systematic barriers exist and contribute to breastfeeding rates that fall below the national average and short of the Healthy People 2020 goals."

LAST CALL: Community Engagement is seeking a manager for a BreastfeedingUSA Warm Line

Warm Line Manager Position Description: The Warm Line Manager will be responsible for accepting incoming messages and redirecting them to BCs, tracking messages using a platform such as Google forms and/or Excel, and reporting to Community Engagement. The Manager can answer questions, but it is expected that all volunteers seeking to support the warm line will have equal opportunity to respond to inquiries.

Ideally, all incoming responses will be answered within 24 hours. Because of this, the voice message box must be checked at least once per day. We understand that this is a volunteer position, and we will make every effort to provide enough support to meet this goal. As Manager, being able to communicate effectively with the team on availability and schedules will be key to the success of this launch (targeted for late-September).

The process is still in development, and the Manager will be included in this development and testing efforts. All BCs participating in the Warm Line will be responsible for submitting their time answering the warm line messages in their personal monthly CCARs. Time managing the warm line should be reported as national volunteer time. The tracking information gathered by the Warm Line Manager messages will help fine-tune the program to make it more efficient and a more useful tool to families seeking BFUSA support. 
### **Focus on Our BCs**
