9:11pm: Minutes of Oct. 2012 BOD meeting accepted

9:12pm: Financial Report given by Carol Delaney, BOD Treasurer

- A. Google document of report shared with guests
- B. Transformation Project –funds restricted, Indiegogo revenues explained,
- C. Memberships –no growth, professional memberships down
 - a. Benefits needed for professional memberships
 - b. ILCA, publishing of Mothers' Survey paper will raise our profile
 - c. Many breastfeeding FB groups are referring to Breastfeeding USA by name
 - d. Issues with membership renewal letters going into spam resolved
 - e. Survey results showed that many moms do not want to pay memberships
 - f. Memberships need to be made more attractive
 - g. General membership letters should be made available to BCs to hand out in Chapters.

9:27pm: Motion to change Social Networking workgroup job description approved. There is now no official time limit required to volunteer on SN. Volunteers will be accepted at the discretion of the SN workgroup manager. The Operating Committee was informed and accepted this change.

9:30pm: Ali Kulenkamp, SN workgroup manager, presented our new Tumbler campaign to promote Nursing In Public (NIP). Taylor Etchison is leading the project. Photos of moms breastfeeding wherever they are legally allowed to be will be submitted. This is to show the normalcy of breastfeeding and encourage involvement of our Chapter moms and others. The Breastfeeding USA website has links to the campaign and to photo and model release forms. The front page of the website will be changed to advertise the campaign.

9:40pm: Report from Jen Olynyk on Applications and the Comprehensive Course

- A. Approximately 10-12 applicants are accepted into the comprehensive course each month.
 - a. There were 14 new applicants in February.
 - b. 56 candidates are currently working in Module 1; 34 in Module 2: 8 in Module 3.
- B. 3 or 4 candidates are waiting for the next cohort of the Accelerated Course.
- C. Of approximately 102 candidates, about 90% are actively doing coursework.
- D. Writing is completed for all 5 course modules.
 - a. The orientation module will consist of two sections: one for all volunteers and the second for Breastfeeding Candidates only.
